The composition of the Managing Committee shall be as follows for an initial period of four years after which it may be reviewed:

Composition of the Managing Committee

- 1. Chairman
- 2. Secretary
- 3. Treasurer
- Two elected teachers-members of the Academic Council
- One elected teacher-member of the Executive Council
- 6. Three Principals of the Colleges out of which at least one Principal should be from among the Women Colleges.
- 7. One Professor
- 8. One Reader
- 9. One Lecturer
- 10. Three elected representatives from among the benafide members of the Centre, out of which one should be a lady member.

The Vice-Chancellor of the University of Delhi shall be the Patron of the Faculty Cultural Centre.

Members of the Managing Committee belonging to categories 1,2 and 6 to 9 shall be nominated by the Patron. The Patron shall also nominate members listed at category 4 and 5. However, these members shall be from among the elected teachers-representatives in the Academic Council and Executive Council. Out of categories from 7 to 9 at least one member shall be a lady member.

The Treasurer shall be elected from among the members of the Managing Committee as per the rules and regulations framed from time to time.

The Managing Committee shall conduct elections to elect the representatives from among the bonafide members of the Centre as per the rules and regulations framed from time to time.

The election of such members shall be held by secret ballot as per the rules and regulations framed by the Managing Committee from time to time.

One additional elected representative shall be on the Managing Committee for every 50 members or part thereof in case the membership of the Centre exceeds 100 members subject to a maximum of 6 members to be so elected.

: - 3 - :

The Managing Committee may appoint Sub-Committee/s according to its needs and requirements. The Secretary shall act as ex-officio member of all such Sub-Committees.

In case of a vacancy on the Managing Committee, the Managing Committee shall fill the vacancy in relation to vacant place for the remaining period of tenure as per the rules and regulations framed by the Managing Committee from time to time.

The Managing Committee shall frame rules and regulations for managing the day-to-day affairs of the Centre from time to time. The decision will be by majority of votes. However, in case of difference of opinions, the matter may be referred to the Patron whose decision shall be final.

Every member of the Managing Committee shall have one non-transferable vote. In case of tie, the Chairman shall have casting vote.

Tenure

The tenure of the Managing Committee shall be two years and a person shall not ordinarily held the same office for more than two consecutive terms. Further, a person shall not be a member of the Managing Committee for more than three consecutive terms.

The tenure of the Managing Committee shall commence from August 1st.

Meetings

The Managing Committee shall meet as often as the business of the Centre necessitates. However, the Managing Committee must meet at least once in three months.

The Emergency(requisit.oned) meeting of the Managing Committee can be requisitioned by any seven members or 1/3 of the total strength of the Managing Committee whichever may be lower. Such a meeting must be convened by the Secretary within a fortnight from the date of receipt of such a request in writing.

The quorum of all such meetings shall be 1/3 of the total strength of the Managing Committee.

General Body Meeting:

The meeting of the General Body shall be held at least once in a year. The Secretary shall call a meeting of the General Body. The time, date and venue of the General Body meeting shall be decided by the Managing Committee. 1/3 of the membership or 50 members, whichever is less, shall form quorum for the General Body meeting.

Voting Rights

Only those members whose dues are paid uptodate and who have at least six months standing as member of the Faculty Cultural Centre shall have the right to vote and contest the elections. However, this clause will not apply in the case of first elections.

Functioning

The Secretary shall be the Chief Executive of the Centre and shall be responsible for carrying out the day-to-day administration of the Centre under the direction and guidance of the Managing Committee. He shall also be responsible to implement the policies and decisions taken by the Managing Committee. The Secretary shall take all the necessary administrative steps and decisions as per the exigency of the situation.

Resources

The Resources of the Centre will constitute as follows:

(a) Membership fee

Monthly contribution

(b) (c) Grants from the University in the form of

(i) Recurring grant (ii) Non-Recurring grant

(iii) Special grants

(d) Any other means which the Managing Committee may deem fit which is in conformity with the norms of the University laid down for this purpose.

Amendment

One-third members of the Managing Committee can propose an amendment to the Constitution. Such an amendment may be placed before the Managing Committee of the Centre specially convened for the purpose. The amendment shall be treated as carried only when it is passed by the two-third of the members so presented and voted which will not less than 1/2 of the total membership of the Managing Committee. However, the amendment would be effective only when ratified by the Patron. Suspension/Dissolution

The Patron on the recommendations of the Managing Committee may suspend the functioning of the Faculty Cultural Centre for a specified period or may dissolve it provided he is satisfied that the Centre has failed to achieve the aims and objectives in letter and spirit.

Interim Arrangement

The Patron may, due to exigency, dissolve the Managing Committee and appoint another ad-hoc Managing Committee to carry out day-to-day functions of the Centre till such time the normalcy is restored.
